3. **Speaker 1** – LCC's Heather Booth gave a presentation regarding Consumer Goods Testing and Product Safety explain how the Office for Product and Safety Standards works in partnership with Local Authorities throughout the UK

Lancashire County Scientific Services carries out tests on a large sample of products every year and Failure Rate is currently y running at 82%. Products tested include children's toys and clothing resulting in product withdrawal where possible but enforcement of regulations is often difficult since it needs to be carried out in the country of origin. Heather distributed information regarding testing procedure and the reporting of defective/ dangerous products.

Heather's colleague , LCC's Partnerships Development Officer Laura Worden distributed packs detailing current initiatives and developments. Both Heather and Laura were thanked for their efforts which were much appreciated.
